3. HAZARD IDENTIFICATION

Irritating to eyes and skin. Large quantities could be hazardous to the aquatic environment.

4. FIRST AID MEASURES

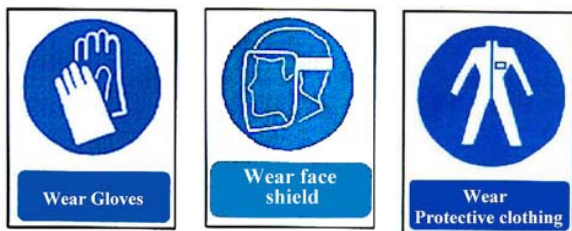
6. ACCIDENTAL RELEASE MEASURES
