Directions:

May be used neat for stubborn marks / stains. For Floors, Walls and Heavily Soiled/Greasy Surfaces: 60-120g per 5L of Hot Water. Remove gross soiling by scraping/brushing surface initially and then brush in the solution. Leave in contact for as long as possible before thoroughly rinsing off with clean water. Paint Cleaning: For routine cleaning of painted surfaces use 7-15g per 5L of water. Steam Cleaning: 30-60g per 5L of water in the detergent solution tank. Carpet Cleaning / Prespotting: (Test for colour fastness) Dilute 30-60g per 5L of water.
